- Approval of your request will depend on the program to which you have been admitted. Deferrals are not available for all UFV programs. Admission to your program of choice is not guaranteed.
- Students may not attend another post-secondary institution during the deferral period. Students who do not comply must re-apply for admission and will need to submit updated transcripts.
- You will be withdrawn from courses after submitting this request.

## Deadlines for Submission

Requests to defer an offer of admission to the Fall, Winter or Summer admission intake must be submitted by the dates indicated below:

**Fall** - August 20   **Winter** - TBD   **Summer** - TBD
